PTA Rocks! We all know it and now its time to spread the word! This year's membership campaign is easy to monitor and easy to promote.

And who doesn't want to achieve success in the always exciting world of PTA

success in the always exciting world of PTA Membership!

As your unit ROCKS its membership numbers, you'll be rewarded for Record Breaking Sales. Register more members this year than you did last year and your local unit will be named a record winner! Increases in your membership of only 5, 10 or 15 members over last year can make your unit a record breaker. You can see your unit in the PTA Membership infamy! Any unit who registers 37 new members over their 2010-2011 membership total will be inducted in the District 37 Membership Rockin' Hall of Fame and will be individually recognized at the 2012 annual meeting. It gets even better! You can win a Grammy! The three units with the greatest increase in membership over their 2010-2011 totals as of December 31, 2011 will receive our Grammy and one free registration to this year's Illinois PTA Convention.

How can your unit receive these rewards? It starts out like every other thing your PTA does: you're going to need a plan. Doesn't have to be elaborate. Set some goals. Make them achievable and manageable for your unit. If you haven't done so already, appoint a Membership Chair and maybe even set up a Membership Committee or Team. Let's think about some things that might help you develop your plan and put it into practice.

• Look at your last year's total membership number. Meeting this goal can be the greatest challenge of all. You'll want to approach all of those past members for renewal of their membership early in the year. This is easy if you have a Back to School event or an annual PTA mailing that you use for your initial membership promotion. These are your tried and true members who don't need much cajoling or convincing. Don't worry if some of your last year's members have gone on to the Junior High or the High School. They are still members of your community. You may want to create a letter or flyer that you can send to these folks to outline benefits of joining your PTA after their children have left the school.

- Consider your recruitment activities carefully. Most units find that a large Back to School event is a great place to sell those initial memberships and in some cases this is all that is needed. Remember that membership is a yearlong process, so if face to face recruiting works best for your unit, it may help to have a few events. Maybe a "Bring a Friend" social just before or after a How about setting up an informational table at another family event later in the fall? Set up a table at every school event. If you have good promotional materials and some solid explanations of the benefits of membership, you may not need to staff that table every time. remember that manning the table will always yield the best results.
- New families to your school—Kindergarten and Early Childhood families, transfers, etc.—are almost always interested in joining. They are the future of your school, neighborhoods and PTA. Do you have a Kindergarten Screening or New Parent orientation event? This is the perfect place to meet and greet and talk to these folks about your PTA and all the benefits of being part of the organization. Be prepared to answer questions about the differences between PTA and other parent groups. Often times these parents have friends outside of your school that may not have PTA. Explaining the organization and all that it does to reach all children can help to convince these folks to join. Don't worry if they are initially hesitant to jump into the PTA game. You might want to welcome them to a meeting or event so they can see the organization in action. Try to identify a neighbor that they know who is an active PTA member. Sometimes finding the right person to extend an invitation to join can make all the difference.

 Don't forget your teachers. Did you have a change in staff? How about support staff? Its easy to explain to these folks the importance and value of PTA, they see your unit in action



all the time. Need help getting out the word? Ask your principal or a respected teacher to send an email or mention the membership campaign at a staff meeting. You can always create a mailer to put into staff mailboxes. Signs in the staff lounge can also be effective.

- Once you've hit your last year's number or if you are struggling to get to this number, its time to go outside of the school walls. The challenge can be finding new groups to target for membership. Think small! Ask members to reach out to student's grandparents, caregivers and their neighbors who may not have any children in the public We are all part of our neighborhoods and all neighbors benefit from strong PTAs and strong schools. Even if you only have moderate success here, you may find a few new members you didn't have before. Don't forget that membership in your local unit is also membership in the National PTA and our goal is to work for every child. Elderly neighbors who have relatives in other states may like the idea that they are supporting a national initiative with far reaching goals.
- Now expand your target out a little wider to include local businesses. Maybe they are a Hot Lunch vendor or they partner with you for a restaurant night. There are also plenty of businesses in your neighborhood that never do business with you, but like other neighbors, they want to see your school and your PTA succeed. Sometimes the folks who would like most to know what your PTA is doing aren't directly inside your community. Do you know a Real Estate agent who does business in your

neighborhoods? Maybe they don't live there, but they will want potential buyers to know that they are involved in this community. They can also be a good voice for recruiting move-ins to your unit.

At this point you may or may not have achieved your goal. If you did, great! Congratulations! If not, don't worry. We have all year to work together to raise our numbers. Don't forget the PTA Web sites can be great resources for lots of ideas. They have great promotional materials that can help you to recruit and retain members. Visit the Illinois PTA (www.ilpta.org) and the National PTA (www.pta.org) Web sites and check it out.

NEWSLETTER- Michele Sheppard

As you begin the year and decide how and how often you are publishing your newsletter, remember that keeping your membership informed is your primary goal.



If you publish an online newsletter, how do you handle those members that do not have access to the internet? Have you considered providing hard copies to those parents?

Are you providing your membership with all the information that they need to be informed participants in your PTA? Some PTAs have reduced the number of issues that they are publishing due to costs. While fiscal responsibility is necessary, have you considered the possibility of producing a shorter newsletter rather than fewer editions? Timely information is very important for your members.

The last item to consider is who receives your newsletter? While a newsletter is a member necessity, consider providing the information to all the families so that they can see what your PTA is doing. If they don't know what the PTA does, they will never get involved. Copies of your newsletters should also be sent to the District Director, District Newsletter Chair, as well as your school district administration and school board.


TECHNOLOGY – Brent Fentem

Is the number of children with cell phones in your child's school increasing? Do you notice adults walking into the school with the cell phone in hand either talking or texting? Are you aware of the no usage of cell phone in school zones law that was passed and/or the no texting while driving law? Most likely if people are walking into the school doors in the middle of a conversation or a text on their cell phone, they were in the process of that while behind the wheel of the car in the parking lot. You may be aware of the threat this can be to everyone, but it is important that we teach others about not only the fines that could result of their ignorance of the law, but the safety and well being of our children they could be endangering.

Use newsletter. website vour correspondence/means you can to educate everyone about the risks of cell phone usage. This is a great form of parent education and definitely falls under the role of a PTA. The State of Illinois has a whole portion of their website dedicated to the campaign: "Drive Now. Text Later.". Inform your community about this campaign and give them the means to help support it and get the word out there. As a PTA, there are sample articles you can use, fact sheets and much more to share with the community.

Ten Tips for Treasurers as the Year Begins

Does your role as the new PTA Treasurer seem a bit daunting? Here are 10 tips to help you get off to a strong start in keeping the job manageable.

- 1. Make sure the financial records of the previous year have been audited.
- 2. Plan and prepare a proposed budget that reflects the goals, programs and past practices of the PTA. Remember, only the general membership can adopt the budget--the board is making a recommendation.
- 3. Plan and prepare a business-like procedure for handling all PTA funds, including the use of both a deposit voucher and expense voucher This will help create a check and balance system of financial safeguards.
- 4. Deposit all PTA funds immediately, in a financial institution approved by the PTA board.
- 5. Review the PTA bylaws to determine any duties required of the treasurer, especially remittance of dues to the state office. Just a reminder, National PTA dues was increased July 1, 2011. The state and national portion of dues is now \$4.25 per person. The first dues remittance must be submitted to the state office postmarked no later than October 1st.
- 6. Make sure that the proper Internal Revenue Service documents have been prepared and submitted. (See the IRS website for some tips on reporting for non-profits)
- 7. Prepare a policy for any returned checks. Determine how you will recover these funds, including any bank fees, before you need to take action.
- 8. Be sure that you are in compliance with any insurance requirements. If you are insured through the Illinois PTA group coverage with AIM, that includes a dual signature policy on all checks, as well as statements being sent directly to someone who is not authorized to sign checks.
- 9. Work with the other members of the PTA to continually evaluate your financial health.
- 10. Ask for assistance when you need it. District 37 is here to help--we are as close as a phone call or an e-mail.

HEALTH/SAFETY – Joyce Stenzel

Using Elizabeth Gilbert's Book, <u>Eat Pray Love</u>, we can use the same three word summary concept to help all of us to start this school year off - TALK PLAY WALK. These three simple words can help all parents to ensure a great start to this upcoming school year.

TALK

Such a simple thing to do, but as school starts, it seems to find the time to TALK more challenging these days with busy family schedules and those electronic devices. Some ideas to get more TALK in your life include: No Electronic Use Hours (like TV/Wii/Computer turned off certain hours), Family Meals (and remember our kids can cook and help with the prep) and use the time wisely on those drives to/from your children activities to catch-up. TALK with your children - it is so important to THEM.

PLAY

All of us need more physical activity in our lives, so PLAY with your children everyday. As highlighted in the National PTA's booklet, <u>Healthy Lifestyles</u> – A Parents Guide,

"In 2005, more than a third of high schoolers reported watching three or more hours of television per day on an average school day. This inactivity is not only harming children's health but affecting children's academic success. Physical activity improves children's academic performance. Studies show that providing more time for physical activity (by reducing class time for academics) can lead to improved test scores, particularly in the area of mathematics. Physical activity programs have also been linked to stronger academic achievement, increased concentration, and improved reading and writing test scores."

So, get outside and active with your children. Kick the soccer ball, shoot some hoops, swim a lap or chase your son/daughter with a quick game of tag. Get moving and you will see improvement in your children and your own lives (along children's grades) as you PLAY with THEM.

WALK

"In 1969, 42 percent of children ages 5 to 18 walked or biked to school; in

2001, only 16 percent did" as noted in the same PTA Parent Guide. So, if you can WALK or bike to school, plan your day to do it and you will be healthy and kinder to the environment, too. Perhaps, you can lead a "walking school bus"—walking groups of students to school—on a rotating basis with other parents can be a great way to help your kids increase their daily physical activity, especially if you have concerns about their safety. To get ideas, check out www.walktoschool.org as we all WALK with THEM.

So, remember these three words to ensure that all of us have a great start to the 2011-2012 school year – TALK PLAY WALK.

A quick reminder if your school PTA is planning a healthy lifestyle program which involve families, students, schools and/or communities, perhaps National PTA can help fund your program this school term. National PTA is awarding up to 10 PTA Lifestyle grants with awards of \$1,000 possible. LEGISLATION – Matthew Rodriguez

Welcome back! I know everyone has been anxiously waiting for the next PTA communication and a new year filled with legislation activities.



On July 8th, 2011 Governor Pat Quinn signed into law House Bill 1204. It is now Public Act 97-0087 which targets violence in elementary schools. The excerpts from the article below highlight the importance of this new piece of legislation.

Illinois school children will get a lesson in peace keeping as early as kindergarten starting this fall, under a suite of education bills that Gov. Pat Quinn signed into law today at a North Side school.

Students in kindergarten through third grade now will study how to resolve conflicts without violence during a unit that spans at least three weeks every year. The new law extends to the youngest students the lessons that now began in fourth grade and continue through senior year.


"It's hard to learn if you are worrying about your safety," Quinn said during a bill signing ceremony at Wells Community Academy High School on the Near North Side.

IMPORTANT INFORMATION FOR PRESIDENTS AND TREASURERS



FILING THE 990-N ELECTRONIC POSTCARD

Over the past three years, the reporting requirement for Gross Receipts for Non-Profits and Charities has been undergoing revision. The current requirement for PTAs, designated by the IRS as 501 c 3 associations, allows filing of the 990-N Electronic Postcard if the PTAs gross receipts for the fiscal year ending on or after December 31, 2010, do not exceed \$50,000.

Completing the e-filing requires 8 items:

- 1. Employer Identification Number (EIN).
- 2. The tax year (i.e. 7/01/10 6/30/11).
- 3. Legal name and mailing address of the PTA.
- 4. Any other names the organization uses.
- 5. Name and address of principal officer (i.e. president during the fiscal year reported)
- 6. Web site address, if you have one.
- 7. Confirmation that the annual **gross receipts** are normally less than \$50,000.
- 8 If applicable, a statement that your organization has terminated operations.
